Scope

This document refers to personal data, this is defined as information concerning any living person (a natural person who hereafter will be called the Data Subject) that is not already in the public domain.

Disclosure

However, **Majestic Interactive** may disclose your Personal Information to meet legal obligations, regulations or valid governmental request. The agency may also enforce its Terms and Conditions, including investigating potential violations of its Terms and Conditions to detect, prevent or mitigate fraud or security or technical issues; or to protect against imminent harm to the rights, property or safety of **Majestic Interactive**, its clients and/or the wider community.

Retention Policy

Where data is held in countries outside the EEA **Majestic Interactive** will always first check that the supplier has data compliance certification.
